Colombian Context Long history of violence

- Thousand Days' War (1899–1902)
- La Violencia (1948–1966)
- Armed conflict (1960s–)
 - Actors
 - Government
 - Left-wing guerrillas
 - Right-wing paramilitary groups
 - Drug-trafficking organizations (DTOs)
 - Civilians
 - At least 220,000 dead

Generalized Violence

Violence against the press

- 130 out of 180 countries
- +150 journalists murdered since 1960s
- 515 attacks in 2019

Gender-based violence

- 90% of victims are women
- Underreporting at 80%
- Only 5% of perpetrators convicted

Case Study

- Jineth Bedoya Lima
 - Colombian journalist
 - Covered law and order matters
- Kidnapped in May 2000
 - Tortured, sexually assaulted
 - Held hostage for 16 hours
- Case became a symbol of impunity
 - Only three people sentenced
 - Masterminds remain free
 - Kidnapped again in 2003
 - Threats still recurrent

Turning point

- In 2019, her case was submitted to the Inter-American Court of Human Rights
 - First case to touch upon:
 - The intersection between violence against the press and gender-based violence
 - Sexual violence in the context of the armed conflict
- Court's decisions are binding for Colombia



Prevention Mechanisms Recommendations

- Threats
 - Improve and integrate threat-monitoring mechanisms, while making them gender-sensitive
- Education
 - Implement educational initiatives to more effectively address violence against female journalists in a post-conflict society

Protection Mechanisms Recommendations

- Protection Program (Programa de Protección)
 - Restructure the National Protection Unit by correcting its systemic problems and incorporating a gendersensitive approach to it
- Reparation
 - Develop non-monetary reparation measures to restore part of the dignity that was stolen from the women journalists of Colombia

Prosecution Mechanisms Recommendations

- Investigation
 - Enhance investigation procedures, offering more rapid, and thus more adequate responses
- Impunity
 - Condemn impunity by strengthening rule of law and State effectiveness

Compliance

- Government policy rather than state policy
- Compliance *vs* effectiveness
- Higher level of compliance
 - Colombia = 44%
 - Other States = 36%
