

## **Contemporary Latin American Contributions to Feminism**

### **Syllabus**

#### **Course Description**

This course provides a broad overview of ideas, discussions and recent debates of feminism and women's social mobilization from Bravo River to Patagonia. We will focus on providing an explanation of the origin of feminism in the XXth century. We will examine the intellectual background, preliminary ideas and ask how the political claims of feminism emerged in several countries. We will study the development of feminism over the last 40 years, and its relationship with political regimes, giving particular attention to women's resistance of repressive governments. Finally, we will consider the critiques developed in Latin America to white feminism, imperialist feminism and colonialism. To that end, we will review examples of indigenous and black organizations and their ongoing erosion of colonial patriarchy and indigenous patriarchy.

#### **Learning Objectives**

The course aims to introduce students to the specific forms of feminism developed in Latin America, including the main contributions and problems confronted, and enhance students' understanding of how intellectual movements result from particular social contexts. (As many materials are untranslated, a minimum of reading-level Spanish is a course requisite.)
